- → The FTA Triennial Review was due for the CSPDC in 2023. The process began in FY23 and concluded in FY24 with an virtual site visit July 31-August 3. The review culminated with only three findings, with corrective actions completed in December 2023.
- → Afton Express celebrated two years of service on September 1. To celebrate, farefree rides were offered on September 1, and pop-events were hosted throughout the month.
- → BRITE Bus again offered free rides on all routes (with the exception of Afton Express) for Election Day, November 7.
- $\rightarrow~$  CSPDC and VRT celebrated Transit Operator Appreciation Day on March 18, and BRITE and Afton Express drivers were honored.
- → CSPDC completed work on the ITS-Mobile Data Collection System project with Passio Technologies mobile data terminals installed on BRITE buses that enabled real-time GPS and electronic data collection (with technical assistance from Kimley-Horn).
- $\rightarrow~$  CSPDC broke ground on the Staunton Lewis Street Hub Rehabilitation Project (with A&E services and construction management assistance from Kimley-Horn).
- → Throughout the fiscal year, route & stop modifications were made to the: 250 Connector (Valley View Senior Apartments & Valley Community Services Board); Afton Express (Fontaine Research Park); Stuarts Draft Link (Amazon Facility-Fishersville).
